Michael Arnis	Renewal Waiver Q&A with HCA Policy Deputy Director, Michael Arnis	A request made to flush out the details before the waiver, as much as possible.  What role does the HCA envision for clinical partners under the renewal waiver?  Arnis explains that this application has focused on Community Based Organizations (CBOs) and not on clinical partners. Yet clinical community linkages will continue to be important. The community information exchange (CIE) needs to be built on the community side as we have already been working on the clinical side.  Adding wraparound services and navigation etc are important. However, if we plan to continue to engage clinical partners, it is not clear what to tell them. It seems like the bottom is dropping out and there is a shift in another direction.  Arnis explains that there is still a commitment to the clinical linkages. We are trying not to fund community	

exchange through waiver dollars but rather use other dollars for this. An request for proposal (RFP) is planned, that would purchase a system and task the vendor with the linkages. We are not talking about it currently due to the legislature requiring a review first, then the RFP.

Is a statewide Community Information Exchange state vendor approach a few years away then?

Arnis explains they are hoping to align the review and RFP but the HCA is not in control and cannot at this time say if this is going to happen. They want to get the review done and make a proposal to the state legislature. They would like this all to dovetail.

Often, we wait for years to develop these things, why not just let us do whatever is needed at the local level?

Arnis asks, are we stopping you?

Interoperability and true care coordination is important, as often care happens outside our region. If we go with a particular platform and the state goes with another one later, we are concerned the possibility that systems are not compatible with the future state platform.

We have struggled to get things up and running. We have technical sophistication but there are still barriers due to 42CFR. The work with MTP is not done and needs to be acknowledged.

Arnis expressed appreciation for these thoughts and this conversation.

Some CBOs are operating on a knife edge of resources. It is difficult to have the capacity to make change even with funding because it goes away and then the program goes away. Some CBOs have policies not to accept grants that do not have long term commitment.

Arnis: Fortunately, the renewal would provide funding for 5 years, and he also realizes this may still not be long enough.

What do we want to achieve with the waiver?

Arnis: We want to meet health related social needs.

The Board will submit public comment from an ACH role perspective. We can finalize and submit formal comment in June.

There are webinars and links available.

Last time 90% of comments were from MCOs. They are looking for a broader range of perspectives.

You all are welcome to offer comments on your own and

Monthly Executive Director report to the OCH Board of Directors – June 2022

### Hot Topics

- The public comment period for the renewal of the 1115 waiver begins May 12. OCH will likely submit comments following a discussion at the June Board meeting. HCA is hosting 3 optional webinars: <a href="https://doi.org/10.1016/j.nc.">Thursday, May 26</a> from 12-1 p.m.; <a href="mailto:Tuesday">Tuesday</a>, June 7 from 5:30-6:30 p.m.
- The <u>Expanding the Table RFP</u> will be posted on June 7 with a July 12 deadline. Board members are encouraged to promote the opportunity.
- Strategic Plan Focus Areas & Action Collaboratives.
  - Together, recovery is possible OCH continued to share partner and community stories via the Recovery Hero campaign. In the month of May, a spotlight blog was posted featuring the <u>Jamestown Healing Clinic</u>. Several additional spotlights are in the works and set to be published in June. The action collaborative met to continue developing a 4-year action plan.
  - Individual needs are met timely, easily, and compassionately OCH contracted with the Rainbow Center to host a LGBTQ+ Core Competency training. The training was well received by the 11 partners from across the three counties that attended and there is interest in pursuing additional trainings in the future.
  - Access to the full spectrum of care The action collaborative met to continue developing a 4-year action plan.
  - Everyone housed OCH staff continue to conduct key informant interviews to inform priorities and projects of the housing action collaborative. Staff have completed 6 interviews and an additional 2 are scheduled with partners across the three counties. Additionally, a partner spotlight was recently posted highlighting the Makah Tribe's Village of Hope, a project funded partially by OCH's 2021 COVID-19 Response Funds.
- Subcommittee reports/updates
  - Executive Committee did not meet this month. Meeting again in late July.
  - Finance Committee did not meet this month. Meeting again in early August.
  - Funds Flow Workgroup Met on June 7 to review 2020 performance incentives and to make a recommendation to the Board on how to allocate extra dollars.
  - Visioning Taskforce- In process of reorganizing this group. An SBAR is forthcoming to the Board – likely in August.
- Upcoming meetings and events
  - VBP Action Group July 12 OCH HQ
  - Executive Committee July 26 Virtual
- Administrative & staffing updates
  - Ren Mack-Hazelwood joined OCH in mid-May. Ren will work on the Care Connect program funded by DOH. Welcome Ren!

Dear Sue,

On behalf of the Board of Directors for Olympic Community of Health, we appreciate the opportunity to provide public comments on the draft waiver renewal application that the Health Care Authority (HCA) will submit to the Centers for Medicare and Medicaid Services (CMS) later this summer. We are pleased that Accountable Communities of Health (ACH) are included in this waiver as key partners for the *Washington Integrated Care Assessment* and under the *Taking Action for Healthier Communities* initiative. OCH has leveraged the initial waiver to build and strengthen relationships, improve health outcomes, and is now seen as a key health partner in the Olympic region.

We offer the following comments regarding the draft application:

- It is notable that the core functions and activities of ACHs are missing from this draft application. OCH
  encourages HCA to include some information about the ACH roles in convening, community
  engagement, data and analytics, communication, and broad equity work as these activities are what
  our community members consistently say are most important and these serve as the foundation for all
  other ACH work.
- Consistent with how HCA has communicated, the five-year budget for ACH work is notably decreased compared with the 2017-2021 waiver. OCH encourages HCA to build on lessons learned under the prior waiver and allocate funding to ACHs equitably and not solely based on the number of Medicaid lives in a region. As the smallest ACH from a Medicaid beneficiary count, OCH is large geographically and many of our expenses are comparable to other larger ACHs. OCH recommends a base of funding to ensure that all ACHs have enough money to achieve the work outlined in the application.
- Washington Integrated Care Assessment:
  - OCH encourages HCA to prioritize practice coaching, technical assistance, and training in alignment with the individual provider needs. We do not recommend a "one size fits all" approach, especially for smaller and more rural communities.
- Community Hub model:
  - OCH largely applauds the focus on community-based organizations, and we are **excited to** launch a hub in 2023.
  - o OCH recommends a focus on **continuing to build and enhance community-clinical linkages**. In a rural region such as OCH, many clinical providers have community-based workers including

Community Health Workers, navigators, etc. and allowing for these partners to participate in the hub will be more comprehensive, will better align with patient needs, and will allow clinical providers to continue to participate in activities started under the initial waiver.

#### Health-Related Services:

- As OCH understands this component of the draft application, there are still many details and decisions to work through over the next couple of years. OCH is supportive of the activities and details included in the draft and encourage HCA to continue its approach of allowing for regional flexibility.
- OCH is excited for the opportunity to partner more deeply with Managed Care through this
  program. We look forward to building on our unique strengths and those of Managed Care to
  ensure that social needs are met for our most underserved populations.

### Equity

- OCH is pleased to see a **concrete focus of addressing equity** in the waiver application. This work will build upon many local efforts to reduce inequities and build capacity.
- OCH encourages HCA to ramp-up the timeline for this important work. Given current and prior ACH work in this area, a one-year planning timeframe is likely not needed.
